EUCOSHOT D-A is a multi-purpose admixture designed to accelerate the normal setting rate of shotcrete, increase strength development at all ages and improve workability. EUCOSHOT D-A does not contain any chloride ions.

NOTE: This product does not protect the mix from freezing. This product will allow the shotcrete to gain strength at a faster rate.

Appearance-EUCO SHOT D-A is a white, free flowing, fine grained powder.

PACKAGING

EUCOSHOT D-A is available in 50 lb (22.5 kg) bags, or in 3,300 lb (1,500 kg) sacs.

Shelf Life: 1 year in original, unopened package.

DOSAGE

EUCOSHOT D-A is dosed between 0.75% and 1.5% by weight of cementitious materials, depending on the cement, the rate of acceleration required and the ambient temperature.

TECHNICAL INFORMATION

The following results are from samples obtained by spraying with industry-standard equipment in a laboratory setting using 0.8% EUCOSHOT D-A in a standard industry mix.

DIRECTIONS FOR USE

EUCOSHOT D-A should be blended thoroughly with the dry shotcrete mix before introduction to the shotcreting equipment.


PRECAUTIONS/LIMITATIONS

- EUCOSHOT D-A should never be used in a wet mix as initial set can occur in as little as ten minutes after contact with water.
- It is recommended that test panels be shot to determine the best amount of acclerator for a specific application
- Store EUCOSHOT D-A in a dry area, free of relative humidity.
